GENERAL NOTICE

CALL FOR NOMINATION OF CANDIDATES TO SERVE ON THE MPUMALANGA TOURISM AND PARKS AGENCY (MTPA) BOARD

The Member of the Executive Council (MEC) responsible for the Department of Finance, Economic Development and Tourism, Honourable **S E Kholwane** hereby, in terms of **section 10 (2)** of the Mpumalanga Tourism and Parks Agency Act, 2005 (Act No. 05 of 2005), calls for the nomination of persons to fill two vacancies of non-executive Members of the Board of Mpumalanga Tourism and Parks Agency.

The appointment shall be subject to **section 6** the Mpumalanga Tourism and Parks Agency Act, 2005 (Act No.5 of 2005) which provides that persons appointed shall be:

- (a) fit and proper persons;
- (b) South African citizens;
- (c) broadly representative of the Province; and
- (d) persons who have sufficient knowledge of, or experience in the development, funding or promotion of agriculture, property development including the granting of housing loans, trade, industry sector development or investment in respect of the Province, with specific emphasis on Black Economic Empowerment.

Please take further notice that in terms of **section 8** the Mpumalanga Tourism and Parks Agency Act, 2005 (Act No.5 of 2005) a person is disqualified from being appointed a non-executive Member of the Board if such person:

- (a) is a Member of the National Assembly or National Council of Provinces, any provincial legislature, municipality or is in the full-time employment of an organ of state, other than the Agency;
- (b) is subject to a final sequestration order under the Insolvency Act, 1936 (Act. No. 24 of 1936);
- (c) is subject to an order of a competent court declaring him or her to be of unsound mind or mentally disordered or defective;
- (d) has been convicted of any offence in respect of which he or she was sentenced to imprisonment without the option of a fine for a period of not less than three months;
- (e) is in terms of the Companies Act, 2008 ineligible or disqualified from being a director of a company.

All interested parties are invited to submit nominations within 21 days of the publication of this Notice. Confirmation of the availability of the nominee is also required.

The CV of the nominees, including the following information must accompany the nomination:

Identity number; gender; race; designation and responsibilities; contact details (including postal and email addresses); qualifications; current and past areas of expertise; and the names and contact details of two referees.
